Further information on your organisation's commitment to sustainable palm oil	Two key areas for growth in 2011: 1) From 2011 project development is proposed to expand FFI's work on sustainable management and financing of high conservation value forests in Kalimantan. This is dependent on the success of a second phase Biodiversity and Agricultural Commodities Program funding. 2) FFI is assisting the Government of Liberia, the private sector, and NGOs in creating a Liberia RSPO National Initiative. The Initiative and its Technical Working Groups will ensure the sustainable development of Liberia's oil palm sector, producing a National Interpretation of the RSPO P&C and supporting the establishment of a national HCV initiative, providing guidance to the delineation of over 500,000 hectares of proposed new concessions. FFI aims to incorporate biodiversity and social considerations into landscape planning. FFI is well placed to engage with palm oil development in Liberia owing to our experience with the palm oil sector in Indonesia, and our presence and commitment to addressing biodiversity issues in Liberia since 1997.
