- 1. South Sumatra: completed
- 2. West Kalimantan:
- Stage 1 RSPO certification audit completed in February 2008 and then again on August 2010.
- Corrective actions identified from these audits have been implemented with the exception on of some on-going government licensing processes pertaining to the land (legacy issues from date of acquisition).
- Smallholders areas in West Kalimantan are managed under a KKPA so all operational and administrative activities are the same as with the inti. Socialization is on-going. When Inti areas are certified so will the smallholder areas (managed together as one).
- Timing of Stage II RSPO certification audit and final certification are anticipated in 2013 depending on pace of government processing on on-going license processes.
- Upon certification based on this audit all volumes of CPO, PK and PKO produced in our company mills will be certified.



- ISCC and ISPO certification audits (Stage 1) will be conducted in October 2012 and Mar/Apr 2013 respectively.

- 2. West Kalimantan: As stated earlier smallholders will be certified along with Inti.
