We have contacted all of our suppliers working with palm oil and as a result have switched many of our supply of major palm oil containing ingredients to RSPO certified mass balance or segregated supply. We will continue to encourage and promote our non RSPO supplier to become certified. The difficulty not is for the suppliers of the smaller percentages of palm oil (less than 2%) - as percentages are such a small volume, it is not deemed necessary for the supplier to become RSPO certified as it is 'not applicable'

For future development work we will aim to only source suppliers with RSPO certified mass balance or segregated where possible.

## Challenges

1 What significant economic, social or environmental obstacles have you encountered in the production, procurement, use and/or promotion of CSPO and what efforts did you make to mitigate or resolve them?

We have a number of suppliers that have no plans on becoming RSPO certified as our volumes that we take from them are not large enough for them to have the implicated cost of becoming certified. Also some of our raw materials contain a small % of palm oil fractions/derivatives which are not available to be sourced as segregated or mass balanced. This is because supplier are reluctant to source the palm oil of which is less than 2% as it is not deemed necessary according to their RSPO certification system. It is 'not applicable'.

We have supported the use of RSPO methods in line with meeting retailers expectations and from this we aim to source all of our raw materials (when possible) from RSPO certified suppliers. Our RSPO certification is communicated throughout the company and to customers when requested.
