Public Notification on upcoming RSPO Initial Certification assessment of ASOSIASI CAHAYA PUTRA HARAPAN and its independent smallholders, in Bukit Sari, Karya Mukti, Kehidupan Baru and Tidar Kuranji Village, Maro Sebo Iilir Sub-District, Batang Hari District, Jambi Province, Indonesia.

ASOSIASI Cahaya Putra Harapan has applied to PT TUV Rheinland Indonesia for assessment of one of their holdings against the Roundtable on Sustainable Palm Oil (RSPO) for Group Certification of FFB Production, RSPO Accreditation and Certification Requirements for Group Certification of FFB Production. The assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

ASOSIASI Cahaya Putra Harapan is an organization of independent smallholders, held in Jambi Province, and registered in deed of notary public No. 07 date March 14th 2018 named ASOSIASI Cahaya Putra Harapan. This organization held to create the welfare for its outgrowers and to promote sustainable palm oil in Jambi Province. ASOSIASI Cahaya Putra Harapan has more than 475 independent smallholders in 452,71 ha plantation area. ASOSIASI Cahaya Putra Harapan has also registered as RSPO member on June 5th 2018 with Member ID Number 1-0252-18-000-00 & Palmtrace ID Number RSPO_PO1000009882.

Scope of assessment:

The RSPO Initial Certification assessment of ASOSIASI Cahaya Putra Harapan in Jambi is scheduled to commence from September 23rd-27th 2019. The assessment shall be carried out for ASOSIASI Cahaya Putra Harapan and palm oil plantation of its independent smallholders. The details of the organization to be assessed are as follows:
