Invitation to comment on RSPO Recertification cum Transfer Assessment of Kuala Lumpur Kepong Berhad (RSPO Membership No: 1-0014-04-000-00), Plantation Management Unit – KLK Changkat Chermin POM & Estates, Perak, Malaysia

Kuala Lumpur Kepong Berhad has commissioned Intertek Certification International Sdn Bhd for the assessment and certification of its Plantation Management Unit, KLK Changkat Chermin POM & Estates against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria (RSPO P&C) 2013 and in line with the Malaysian National Interpretation (MYNI) 2014 and RSPO SCCS 2017 for Palm Oil Mill.
