Notification of RSPO Re-Certification of ANJA Siais POM – PT ANJA Siais subsidiary of Austindo Nusantara Jaya Agri (RSPO membership number 1-0032-07-000-00 on 27 February 2007)

Dear Stakeholders,

Austindo Nusantara Jaya Agri has applied to PT Mutuagung Lestari for RSPO Re-Certification ANJA Siais POM and its supply bases, located in Village of Pardomuan, Sub District of Angkola Selatan, District of Tapanuli Selatan, Province of Sumatera Utara, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT ANJA Siais has been taking an active role in the RSPO certification processes and implementing programmed to continue RSPO certified. ANJA Siais POM has been registered in PalmTrace IT Platform with member ID RSPO_PO1000001992. PT Mutuagung Lestari has arranged to conduct the Re-Certification of PT ANJA Siais which has 1 (one) mill and 2 (two) estates on **15 to 19 July 2019**

As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
