Notification of RSPO Initial Assessment of RSPO de Alianza del Humea S.A.S, Colombia RSPO Membership: 2-0970-19-000-00

To Whom It May Concern:

Alianza del Humea S.A.S, located in Colombia has commissioned SCS Global Services to conduct an RSPO Initial Assessment of its palm oil mill and supply basin located near Km30 vía Cabuyaro – Paratebueno, Cabuyaro, Meta, Colombia. The assessment will be conducted of 01 Palm Oil Mill and 06 Independent Outgrowers.

SCS Global Services plans to conduct the Initial assessment of the Alianza del Humea S.A.S mill from **10-14 October 2022**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&Cs for the **Colombia/November 2020**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
