Transportation delays due to 2017 Atlantic/Gulf of Mexico hurricanes Harvey and Irma closed ports and delayed palm oil shipments across the industry. The inability to receive offshore palm oil supplies due to extreme weather increased palm oil costs for Conagra Brands. We mitigated the impact of this by developing spot contracts with suppliers who had readily available palm oil supplier already in the US. Our mitigation strategy avoided production delays. Conagra Brands discloses financial impacts in compliance with applicable regulations. Conagra Brands did not experience a material financial impact from this driver warranting external disclosure based on this approach. There was no resulting impact on product pricing.
