- a. All agreed that the ceiling cumulative management area is 500 ha.
- b. The medium grower is allowed to get RSPO certified through 3 (three) pathways:

Option 1, AR raised an issue if growers could sell partly to the certified mills and the rest to another mill. Responding to this query, JM and SY stressed that as part of the supply base of a single mill, which is the owner of the certificate, the grower can not sell and claim its certification to another mill. MC supported SY with regard to avoid double counting, if the grower is allowed to sell to more than one certified mill. SY also said that the grower can sell both physical and credit, CSPO and CSPK, to the mill which then carry out trading through PalmTrace.

Option 2 in which the medium grower forms a group then gets certified under group certification by compliance to the full P&C 2018 (minus Criteria 3.8 on Mill). EL argued why the group can only sell the physical but not credit. Claims for CSPO and CSPK can only be made by the certified mill that purchased the certified FFBs. EL also proposed to mix the medium and smallholders in a group. JM responded that mixing types of producers such as medium growers and smallholders is not allowed under the group certification.

MG concluded that the MGTF shall explore If the Group Manager has an option to sell via credit for CSPO, CSPKE, CSPKO. This would require acceptance of OER for CPO and CPKO for this category of producer.

This logic is also applied to the independent smallholders that would be required to create MGCSPO, MGCSPK, MGCSPKO category in Palm Trace.

c. HKT viewed that the hardest option was Option 3 as the hardest one due the individual medium grower can not sell credit nor sell CSPO or CSPK. MC echoed this issue by saying there should be no discrimination applied, in terms of where the mill, logistic to go to the mill. MC viewed that the 3 (three) options could be simplified as Option 1 Certification is part of the mill; Option 2. Certification under the group; and Option 3 Individual Certification. FN also with HKT who argued that the grower in Option 3 can sell credit.

SY responded by saying that the mill that purchased certified FFBs can claim CSPO and CSPK.
