#### 3.0 <u>RSPO Secretariat Updates</u> RSPO Secretariat:

- P&C 2024:
  - June 2024 RSPO Secretariat formally release Revision 1.0 of the revised P&C to the Standards Standing Committee (SSC). Revision 1.0 will be the basis of feedback, engagement and consultations activities planned over the next 3-4 months, ahead of an anticipated adoption of the revised P&C and ISH standards at the RSPO General Assembly scheduled for mid-November 2024.
  - Three files which comprise the current draft of Revision 1.0:
    - StandardsRevision\_Summary\_June2024 (PDF): Summary slide deck with key changes and schedule for public consultation/expected adoption.
    - P&C 2024 Criteria and Indicators Revision 1.0\_Ver2.3\_forDistribution (MS Excel): Full wordings of Revision 1.0 of the revised P&C standards.
    - P&C 2024 Part I (Growers) Revision 1.0 Ver 2.3\_ForDistribution (PDF): Mock-up Revision 1.0 full document showing what the revised standards are expected to look like as a published document. Contains introduction, preamble scope, drafting guidelines, implementation timeline as reference. Principle 1 has been incorporated into this draft document as an example.
    - Revision 1.0 will also be sent to the Assurance Standing Committee (ASC), the Smallholder Standing Committee (SHSC) and the Market Development Standing Committee (MDSC). The Secretariat will also begin distributing Revision 1.0 to the relevant Working Groups (WGs) and Task Forces (TFs) that report to the SSC as part of the feedback, engagement and consultation plan and schedule.
    - Quick recap of the process so far, the RSPO Secretariat was directed to look into substantive/critical issues raised by the Standards Revision Task Force 4 in the production of Draft 3 in September 2023. The directive was to consider how Draft 3 could be redrafted for clarity, auditability, implementability, and relevance, as well as propose technical/process solutions for the substantive/critical issues which could not reach consensus at Task Force 4.
    - The Secretariat has approached this new responsibility seriously, and we

have taken a forensic and holistic look at the P&C and ISH standards from multiple perspectives, including scope, supporting structures, change management/implementation transition, and grievance risk. Our proposals have been discussed with the <u>Standards Revision Steering Group</u> for feasibility and consideration, and incorporated into Revision 1.0 where considered appropriate.

- Regarding process and approval of the revised standards, we would also like to provide some clarity on the processes going forward, given that the directive to the Secretariat in September 2023 is a variation of existing processes within the Terms of Reference for the Standards Review.
- The <u>Standards Review ToR</u> states that:
  - (page 5, line 4) "The Standard Review Task Force is the body that assigns tasks to, and receives proposals from, a range of thematic Technical Committees and makes consensus recommendations regarding the standard's content and revision to the Standards Standing Committee."
  - (page 5, line 16) "The final recommended revised Standards shall be checked by the Steering Group who will have ultimate decision-making powers on issues where consensus could not be reached by the TF. The RSPO Standard Standing Committee (SSC) will ensure that the appropriate requirements outlined in the RSPO Standard Setting SOP have been complied with and shall then be recommended for BoG endorsement."
- Given that the Standard Review Task Force has been officially disbanded, the RSPO Secretariat is currently serving the functions of the Task Force. Per the ToR, the Secretariat will now be required to engage and consult members and stakeholders, including former members of the Task Force and Technical Committees, for feedback and proposals based on Revision 1.0.
- With the aim of achieving consensus, the Secretariat will continue to consult with the Steering Group and the SSC as the engagement and consultation activities are underway. The ToR indicates that the SSC shall hold decision-making powers on the standard's content and the version of

the revised standards to be recommended to the BoG for endorsement. In parallel, the Steering Group will continue to hold decision-making powers on issues where consensus may not reached as part of the engagement and consultation activities.	
Our thanks - from the RSPO Secretariat we would like to express our appreciation for the opportunity to contribute to making RSPO standards clearer, more auditable, more implementable, and more relevant. We do also wish to apologise for any delays, miscommunications, transparency, or lack of engagement perceived as part of our undertaking of this considerable responsibility, which we have approached as best we could in earnest and with neutrality.


# 4.0 SR Unit and SRWG

- SR Unit Activities overview
  - SR Scorecard <u>Announcement</u> on 8th July:
    - Deadline to complete MyRSPO SR Section 5th August (internal- 20 August) → SR Scorecard update Sept24.
