- 5. Secretariat to sit with Impact team on the detail requirements of concession boundary data, in particular related to smallholders context (PIC : JM/IM)
- 6. Secretariat to circulate the NPP Update document and also other relevant document up for Public Consultation to the SHWG members (**PIC : JM**)

- Key significant proposal of NPP Update draft :
  - a. No more on going planting submission, all will be considered as new planting
  - b. Certification Body (CB) must do both desk and field verification
  - c. CB will be the one who submit the NPP notification to RSPO
  - d. CB verification statement will only valid for 30 days, from the date of submission
  - e. Assesment report produced under NPP must not be older than 5 years time

Within the RSPO T & T a subgroup is s set up to review the RSPO GreenPalm/Credit trade system. Marieke Leegwater has signed up to participate to represent SH interests on behalf of Solidaridad. She will also try to act as a linking pin between this WG and the RSPO SHWG. It would be good to have some more representatives of this group in the subgroup to ensure the input form SH perspective is broad and balanced. Uki indicates she is intrested to participate. Sharifah will nominate someone of Felda and give a name to Marieke for her to inform the secretariat of the subgroup.

#### HCV – Simplified Guidance

- 1. After the fieldtesting HCV Resource Network came to conclusion the Risk assessment approach was too complicated to do at SH level

- 2. Are we happy for CI tool to be used for high risk/no expansion
- 3. What needs to happen in areas where there is expansion but in low risk area
- 4. What needs to happen for SH who want to expand in high risk area
- 5. Already decided RSPO RSSF can pay for the assesments
- 6. Define 'expansion for Independent SH': NPP for every tree?- that cannot be workable.

#### Actions:

- 1. New iteration of approach no expansion/low risk- Anders
- 2. Find information mapping: Make available to HCV /SHARP compensation Task Force team
