

Opening Address

The RSPO is pleased to publish the RSPO ACOP Digest (RAD), based upon the data collated from the Annual Communications of Progress (ACOP) reports that were submitted by its members for the year 2013/2014.

Through active engagement with the RSPO members, we have been able to make the reporting data this year more specific. We are pleased to announce that the ACOP reporting system is now further enhanced to a more efficient and member-friendly version.

As per the Code of Conduct, only Ordinary and Affiliate Members that joined RSPO before the first of June 2013 were obligated to submit their respective ACOP reports. Members from all stakeholder categories were required to submit their ACOP 2013/2014 reports with the questions varying for each category to appropriately reflect the actual activities, distinctive contributions and level of commitment of each organization towards sustainable palm oil.

Due to the ever increasing number of RSPO members, the number of members who were required to submit their ACOP this year has increased by 34%. Moreover, the total number of submissions this year has increased in respect to the past years.

At RSPO, we believe that progress is unavoidable and the ACOP is a fundamental tool to keep track of positive changes in the palm oil industry. Stakeholders that have shared their plans towards sustainable palm oil are demonstrating their commitment to play an active part in transforming the palm oil market.

An essential aspect of the ACOP remains the submission of Time-Bound Plans (TBP), which enables RSPO to gauge the commitment of all stakeholders towards 100% RSPO-certified sustainable palm oil. We have recorded this year the reporting of more challenging commitments, with a number of companies setting their target to source 100% certified sustainable palm oil by 2015. We look forward to see this become a reality.

RSPO has noted current stakeholders' consistent improvements, and we now look forward to see all members aspire to more robust transformation towards truly sustainable palm oil.

On behalf the RSPO Secretariat, I thank all our members that carried out their responsibility in submitting this year's ACOP.



Summary of Submissions

OVERALL STATUS OF SUBMISSIONS BY CATEGORY



The number of members required* to report this year increased by 34% (855 compared with 639 in 2013).



This represents roughly half (46%) of the active membership of 1,854 organisations**.



In total, 507 (59%) of those required to submit their ACOP did so and a further 116 members reported voluntarily, bringing the total number of submission this year to 623.



In total 415 or nearly two-thirds (67%) of all submissions reported consistently for the last two ACOP years (2013 and 2014).



However 348 (41%) members who were required to report failed to do so this year



Of these, 168 failed to report for the last **2 years running**.



This represents roughly 20% of the required membership.



Of these, 41 failed to report for the last **3 years running**.



This represents roughly 5% of the required membership.



Identity Preserved (IP) Palm Oil

Sustainable palm oil from a single identifiable certified source is kept separately from ordinary palm oil throughout the supply chain.

Segregated (SG) Palm Oil

Sustainable palm oil from different certified sources is kept separate from ordinary palm oil throughout the supply chain.



Mass Balance (MB) Palm Oil

Sustainable palm oil from certified sources is mixed with ordinary palm oil throughout the supply chain. Mixing of sustainable and conventional palm oil is allowed if it is monitored administratively through RSPO eTrace: www.eTrace.rspo.org



Book & Claim (BC) Palm Oil

The chain is not monitored for the presence of sustainable palm oil. Manufacturers and retailers can buy a GreenPalm certificate from a RSPO-certified grower.


