RESPONDING TO REAL SUPPLY CHAIN ISSUES





DEMAND FOR SUSTAINABLY SOURCED COCONUT PRODUCTS OUTPACES THE SUPPLY AND WEAK SIGNS OF IMPENDING SOCIAL, ENVIRONMENTAL AND SUPPLY CRISIS ARE SHOWING

Consumers and buyers are increasingly seeking sustainably sourced coconut products in a context of demand outpacing supply with declining yields due to senile trees, lack of replanting and a new generation of farmers reluctant to inherit farms, fearing a cycle of poverty, environmental degradation, and unresolved social issues.

STATUS QUO IN THE MARKET UNTIL NOW

Less than 1% of coconut production is engaged in sustainability assurance programs with the upstream industry meaning investments are not reaching farmers. Today's assurance schemes used in coconut are not addressing the underlying systemic sustainability issues outside the farms stemming from lack of collaboration along complex supply chains.

COMPANIES DUE DILIGENCE PROCESSES ARE HITTING BOTTLENECKS AND LOSS OF TRACEABILITY

Preventing risk management and responsible sourcing practices due to a lack of transparency

MISSED OPPORTUNITIES TO SCALE IMPACT WITH THE PUBLIC SECTOR

with most private sector sustainability projects are missing linkages and collaborations with governmental agencies and public development agencies

SUSTAINABILITY RISKS ARE INCREASINGLY DOCUMENTED IN THE PRESS.

90% of farmers living below poverty threshold (PCA 2023) with a majority being food insecure with no social protection... Limited access to market, finance and technical know-how, increasing senility of plantations and lack of replanting traps farmers in a vicious cycle of poverty

We need to act now, it is not because NGO's reports' are not slamming the sector that the weak signs of social, economic and supply crisis are any less important. It is key for the sector to act collaboratively to avoid turbulences and disruptions in the future"
