Our total palm uptake in 2023 was 2,386 MT compared to 4,600 in 2022. Our total uptake decreased due to lower production volumes for some products that have palm as a key ingredient. We continue to make RSPO palm a part of our procurement process and validate our uptake each year. We also make efforts to report transparently about our palm volumes in our Impact/ESG reporting. In 2022 approximately 15% of palm is non-certified and was covered by RSPO credits, In 2023 14% will be covered by credits.

We are continuing to work with suppliers to transition products from Book & Claim to physical supply chain (MB/SEG/IP), where physical supply chain sources are available in order to meet our target of 100% RSPO certified palm oil. Our current target year is 2024 which we are planning to extend to 2027.

We are finding it more challenging to transition to physical supply chain sources for select food products and many of our personal care products.
