DSM is only using a few products derived from Palm Oil or Palm Kernel Oil derivatives. 2023 volumes reflect a # 21% decrease compared to 2022 which is linked to destocking, slowdown of the economy, with customers ordering less and lower demand overall.

Others

There are only limited palm oil/Palm kernel oil derivatives RSPO Mass balanced or segregated available on the market. The price premium for these qualities cannot always be absorbed by the market and in non food related markets (feed for instance) the RSPO awareness is not yet there. Difficult to promote RSPO products versus competition which is not necessarily adopting the same RSPO philosophy as dsm-firmenich.
