

ORGANIZATION PROFILE

YAYASAN KELAPA SAWIT BERKELANJUTAN INDONESIA (YASBI) or THE INDONESIAN SUSTAINABLE PALM OIL FOUNDATION (ISPO) is a non-profit organization which established on a Legal Notary Certificate by Suparman Hasyim, SH - No.03/July 6, 2009 and registered by Ministry of Law and Human Right of The Republic of Indonesia. Its scope of work is **OIL PALM of Environmental/Social Sector**.

The foundation opens an office in Jakarta and currently operates without branch. The founding committee of ISPO is stakeholders who previously had backgrounds in and dedicated to the Indonesian oil-palm sector, among these are:

1. DR. Asril Darussamin. He is currently responsible for a position as Technical Assistant for RSPO Indonesia Liaison Office (RILO). He previously worked for the Indonesian Palm Oil Commission (*Komisi Minyak Sawit Indonesia/KMSI*).
2. DR. Kunkun J. Gurmaya. He is a lecture of Bandung Padjajaran University. He is also involved in steering committee for organizing the guidelines of management and monitoring HCV (High Concervation Value) in oil palm sector under the HCV- RSPO Indonesia Working Group (HCV-RIWG).
3. Rudy Ready Lumuru. He is the former director of Sawit Watch Indonesia and also the former member of RSPO Executive Board.
4. Ir. Purwo Susanto. He is the former National Coordinator Program for Oil Palm in WWF Indonesia and also the former member of RSPO Executive Board. He currently takes hold of Deputy Chair of HCV-RIWG.

Besides endorsing to the establishment of sustainable oil palm plantation development concepts in Indonesia, by helping the arrangement of various relevant indulgences and other supporting materials as well as socialization and trainings on RSPO/HCV, the YASBI also assists wide-ranging levels of parties in oil palm plantation sector to conduct HCV/SIA (Social Impact Assessment) assessments for their own plantation estates; both developed and to-be-planned areas.
