This is to inform that the above Management Unit under the Parent Company IOI Corporation Berhad with RSPO membership number 2-0002-04-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit (RA-03)/Surveillance Audit at Bukit Leelau POM and its supply base, located at Muadzam Shah, Pahang. 
