



Notification of RSPO Re-Certification Assessment of GOPDC, Ghana RSPO Membership: 1-0005-04-000-00

To Whom It May Concern:

GOPDC of Ghana has commissioned SCS Global Services to conduct RSPO Re-Certification Assessment of its palm oil mill and supply bases located at Kwae Near Kade, Kwaebibirem District – Ghana. The assessment will be conducted on 1 Palm Oil Mill, 2 Oil Palm Plantation Estates and a smallholder scheme.

SCS Global Services plans to conduct the Re-Certification assessment of GOPDC from **27**th **to 31**st **January 2025**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&C for **Ghana/2019**.
