## INDEPENDENT SMALLHOLDERS

Independent smallholders are self-organised, self-managed & self-financed & have more autonomy to choose how to use their lands, which crops to plant & how to manage them.

Characteristics of independent smallholders crop

#### **ESTABLISHMENT**

- Seedlings sourced directly from private nurseries
  - Development costs, e.g. land preparation, mostly self-funded

#### **MAINTENANCE**

- Self-harvested and maintained
- Maintained by casual workers or contractors
  - Organised via dealership who maintains and harvests crop

#### **TRANSPORT**


- Direct transport using own vehicle
  - Dealers organises transportation of fresh fruit bunches (FFB)

#### **POINT OF SALE**

- Dealership
- Direct to mill or mill appointed dealer

Independent smallholders are free to negotiate to obtain the best price for their crop, therefore having greater bargaining power, particularly where they form a well-organised group. However, in reality, the number of potential buyers for their crop may be limited.


#### **ISSUES & CHALLENGES FACING SMALLHOLDERS**





# BENEFITS OF PARTICIPATION IN CERTIFICATION

Certification potentially increases smallholders' financial capital, giving them more income. Participation increases volume and quality of production, opening opportunities for a higher income. Understanding the Good Agricultural Practices means timely application of fertilizer at the right dosage, increasing plantation's productivity.



#### DIRECT EFFECT

Provides farmers with necessary training to become certified. Farmers' organisations are trained by certification facilitators (companies or NGOs) and in the process, increase networking opportunities and **improve** skills and knowledge.

Majority smallholders think that farmer organisation's staff are better trained and their services improved. They also have more opportunities to participate in the organisations.



#### IMPROVED KNOWLEDGE TRANSFER

Smallholders are trained on **Good Agricultural Practices** – one of RSPO certification requirements - to ensure methods are applied safely and sustainably to create better quality fruits.

Mills are encouraged to educate and train their suppliers. This would improve the relationships and collaborations between both parties.



#### SAFE WORKING ENVIRONMENT

Smallholders given information on safe use of chemical pesticides and safe ways to deal with chemical waste. They are also introduced to healthy and safe working conditions, first aid, and ways to deal with fire, which in turn, contribute to better health conditions.

Also, smallholders get access to elements of physical capital such as safety tools, chemical storage systems and sanitary rooms.

**Natural Capital**. Thanks to the rigid and careful planning and implementation of the process, certification also indirectly goes a long way in conserving soil and water quality, thus protecting the biodiversity of the land used for oil palm cultivation.


#### RSPO SMALLHOLDER SUPPORT FUND (RSSF)

Support programme for smallholders by RSPO

Between 2013 and 2018, RSSF received a total of 101 applications and has approved 39 smallholder projects.

## What can RSSF be used for?

#### Certification

almost 50% of the RSSF grant goes towards the activities which assist smallholders in preparing for certification.

#### **Audit Cost**

100% of the audit cost for all potential certification processes of independent smallholders groups with the option to include one surveillance audit for each applicant. This is one-off only.

#### **Impact Project**

any project other than the projects and audit costs mentioned above including initiatives to develop tools that help smallholders comply with RSPO certification such as mapping, HSV assessments and participation in jurisdictional areas.

#### Who can apply for RSSF?



A legal entity or registered smallholder group

Those with sufficient experience in working with smallholders or group manager





Those wanting to support and promote the production of sustainable palm oil i.e. NGOs, partners, etc.
