Solvay continues to engage customers on our ability to supply RSPO certified ingredients through direct customer interactions, industry meetings, and social media. In 2023, pending market availability & economical viability, we plan to significantly and pro-actively increase our share of RSPO MB sourcing. To accompany that, we work to support our customers and distributors in their efforts to understand requirements related to supply chain certification. Solvay ensures to keep all employees informed of RSPO related updates through internal communications and training, to enable effective engagement with our suppliers and customers all along the value chain. We also work with our suppliers to have an accurate view of our traceability in our value chain and through our responsible sourcing policy.
