Asian oleochemical markets in 2022 showed an unprecedentedly volatility. In that tight situation, we sourced more volume to cover our customers' non-certified demand. The volume of certified materials in 2022 has no big difference from that in 2021. Meantime, as explained above, since we sourced significantly more volume of non-certified volume in 2022, the percentage in Question PT.2.2 in 2022 became significantly lower than that in 2021.
