On May 1st of 2021 the bakery activity of Wouters nv was acquired by the company Zeelandia HZJD. The oils & fats activity of Wouters was sold to Remia Group on the same day. This explains the lower total volume of palm oil and the remarkable higher percentage of RSPO certified palm oil of 38% of the total volume.
