In several cases, sufficiently large enough quantities of certified inbound feedstocks were purchased during 2020 to cover processing requirements during 2021 without having to purchase additional certified materials. As a result, the purchase intake ratio was significantly reduced in 2021 relative to 2020. Actual consumption of certified materials did not change in any dramatic manner from 2020 to 2021.
