Mercuria is a global energy trading group. As part of its activities, it trades biodiesel, mainly for the European market. The group buys and sells physical biodiesel as well as paper biodiesel for risk management purposes. While Mercuria does not trade palm-oil based biodiesel, it can carry palm-oil certificates when transaction biodiesel in its generic form (FAME). The European legislation requires that biodiesel complies with certification system, including ISCC. All biodiesel traded by Mercuria is certified by ISCC. The Group is not producing palm oil based biodiesel in its refinery units. As such, Mercuria is not purchasing physical palm oil cargoes.
