Certified oil palm products are outsourced from RSPO Supply Chain Certification (SCC) certified (millers/refiners/trader). It is delivered from country of origin to Philippines through a foreign vessel. It is then transferred to local barges and loaded to company owned lorries for transport to Mt. Makiling International Oil, Inc. plant for storage (dedicated tanks) and processing in the refinery section. Quality is enhanced by undergoing bleaching and deodorization processes to become highly refined RBD Palm Oil and /or Palm Olein.

Identification of certified sustainable palm oil from conventional palm products was established by including the model scheme of the refined and delivered commodity as well as the RSPO SCC Certificate number of the organization in all accompanying documents of the delivery, such as CoA, Delivery Receipt and Sales Invoice.
