He helped create the Cerrado Manifesto Statement of Support group to de-couple deforestation from increased soy and cattle production in Brazil's Cerrado and is responsible for global engagement of demand companies under the Collaboration for Forests and Agriculture project.

Nursanna Marpaung is the Secretary General of the Labour Union Federations of Forestry, General Industry, Plantations and Agriculture, based in Indonesia. HUKATAN's objectives include fighting for the normative rights of workers in accordance with regulations, fighting for prosperity and maintaining dignity and value and uphold human rights, through social dialogue building, influencing labour policies, organising education and training, advocating for labour, research and campaign issues.

As the Secretary General of HUKATAN, Nursanna's responsibilities include conducting dialogue with the government, companies and corporate associations, connecting with affiliates and donors responsible for the administration of the office. Nursanna is also the Executive Secretary of JAPBUSI (Indonesian Palm Oil Workers Union Network), where she engages with the government, Gabungan Pengusaha Kelapa Sawit Indonesia (GAPKI) and International Labour Organization (ILO) on issues regarding Safety and Health (Kesehatan and Keselamatan Kerja, K3), child labour, women workers, wages, workers employment status and labour inspection.

Her most recent educational background is in Theology. To fight for humanity and to further improve her capacity, she attended training from the ILO, Building and Wood Worker's International (BWI), International Trade Union Confederation (ITUC), CNV International Foundation (CNV) and from the Ministry of Labour.
