Dear Stakeholders.

This is to inform that Aoluk Oil Palm Collaborative Farming Community Enterprise with RSPO membership number (1-0383-22-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification (Eligibility, MSA and MSB). Group office is located at 99 moo 2, Aoluk-Tai Sub-district, Aoluk District, Krabi Province, 81110 Thailand. The audit will be conducted from 01-02 July 2024 against the requirements of RSPO Independent Smallholder Standard For the Production of Sustainable Palm Oil, endorsed by the RSPO Board of Governors and adopted at the 16th Annual General Assembly by RSPO Members on 19 May 2022. The organization was legally established on 04 November 2019. Organization consists of 33 smallholder members managing 60 land parcels with total area 187.28 ha and 175.95 ha of oil palm plantation. The smallholder member of Aoluk Oil Palm Collaborative Farming Community Enterprise received training, guidance and accompanied by GIZ Thailand RSPO Thailand Coordinator and Department of Agricultural Extension. The smallholder members committed to support sustainable oil palm.


