# <u>Public Notification: RSPO Initial Certification Audit of Pancasurya Agrindo POM, PT. Pancasurya Agrindo, part of First Resources Limited (RSPO Membership: 1-0047-08-000-00)</u>

Dear Stakeholders.

This is to inform that PT. Pancasurya Agrindo – Pancasurya Agrindo POM, subsidiary of First Resources Limited, with RSPO membership number (1-0047-08-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification Audit located in Riau Province. The audit will be conducted from 13-18 May 2024 against the requirements of RSPO P&C 2018 – Indonesian National Interpretation 2020. The supply chain model is Mass Balance.

Organization background: First Resources Limited is one of the leading oil palm plantation companies in Indonesia. We are an upstream operator with primary business activities in the cultivation and harvesting of oil palms, and the processing of fresh fruit bunches into crude palm oil for local and export sales. Today, we manage more than 200,000 hectares of planted oil palm plantations and operate 17 palm oil mills in Indonesia. Our plantations produced more than 3.0 million tons of fresh fruits bunches and 881,062 tons of crude palm oil in 2022. PT. Pancasurya Agrindo – Pancasurya Agrindo POM is located in Rokan Hulu Regency, Riau Province, Indonesia with certification unit consist of 1 (one) palm oil mill, 1 (one) oil palm estate under company management.


