Triputra Agro Persada Tbk. (RSPO Membership number: 1-0038-07-000-00) has submitted to PT SGS Indonesia to conduct an RSPO P&C recertification assessment for one of its management units, namely PT. Gawi Bahandep Sawit Mekar and its supply bases with RSPO Palm Trace Number: RSPO\_PO1000001618.

The scope of this assessment is PT. Gawi Bahandep Sawit Mekar with 2 units of mills and 3 units estates as FFB suppliers, located in Jahitan Village, Seruyan Hilir District, Seruyan Regency, Central Kalimantan Province, Indonesia, against the requirements of the RSPO P&C 2018 National Interpretations for Indonesia, (INANI) April 2020, together with the RSPO Certification System (2020) document.

Triputra Agro Persada has been a member of RSPO since June 27, 2007. PT. Gawi Bahandep Sawit Mekar as part of a subsidiary of Triputra Agro Persada is a company engaged in the operation of palm oil mills located in Jahitan Village, Seruyan Hilir District, Seruyan Regency, Central Kalimantan Province, Indonesia, making a significant contribution to the growth and development of the palm oil industry. With a commitment to sustainable practices, PT. Gawi Bahandep Sawit Mekar emphasizes environmentally responsible methods in palm oil production. The company is a member of the RSPO and has been active in the RSPO certification process and plans to obtain RSPO certification for all its management units. PT SGS Indonesia plans to conduct this assessment on November 5 – 10, 2024.
