Public Notification: RSPO Recertification Audit of Gunung Makmur POM, PT. Karya Makmur Bahagia, part of Bumitama Agri Ltd. (RSPO Membership: 1-0043-07-000-00)

Dear Stakeholders.

This is to inform that PT. Karya Makmur Bahagia-Gunung Makmur POM, subsidiary of Bumitama Agri Ltd., with RSPO membership number (1-0043-07-000-00) had appointed BSI Services Malaysia Sdn Bhd (“BSI Malaysia”) to conduct the Recertification Audit located in Kalimantan Tengah Province. The audit will be conducted from 19-22 June 2024 against the requirements of RSPO P&C 2018 – Indonesian National Interpretation 2020. The supply chain model is Mass Balance.

RSPO PO ID number of the PT. Karya Makmur Bahagia-Gunung Makmur POM is: RSPO_PO1000001684.

Organization background: Listed on the Singapore Exchange on 12 April 2012, Bumitama Agri Ltd. (Bumitama or the Group) is a young crude palm oil (CPO) and palm kernel (PK) producer with sizeable oil palm plantations in Indonesia. Our core business activities are cultivating oil palm trees, harvesting, and processing fresh palm fruit bunches (FFB) into CPO and PK, which we sell to refineries in the country. Since commencing planting in 1998, Bumitama has increased its total land bank to about 200,000 hectares in primarily three provinces: Central Kalimantan, West Kalimantan and Riau, areas which are well-suited for oil palm industry. As a young plantation player, the weighted average of our oil palm trees is about five years, and only about 25.1% of the planted area has reached peak production age. PT. Karya Makmur Bahagia-Gunung Makmur POM is in Rantau Tampang Village, Telaga Antang District, Kotawaringin Timur Regency, Kalimantan Tengah Province, Indonesia with unit of certification comprise of 3 (three) company-owned estates and 1 (one) palm oil mill with capacity 90 MT/hour.

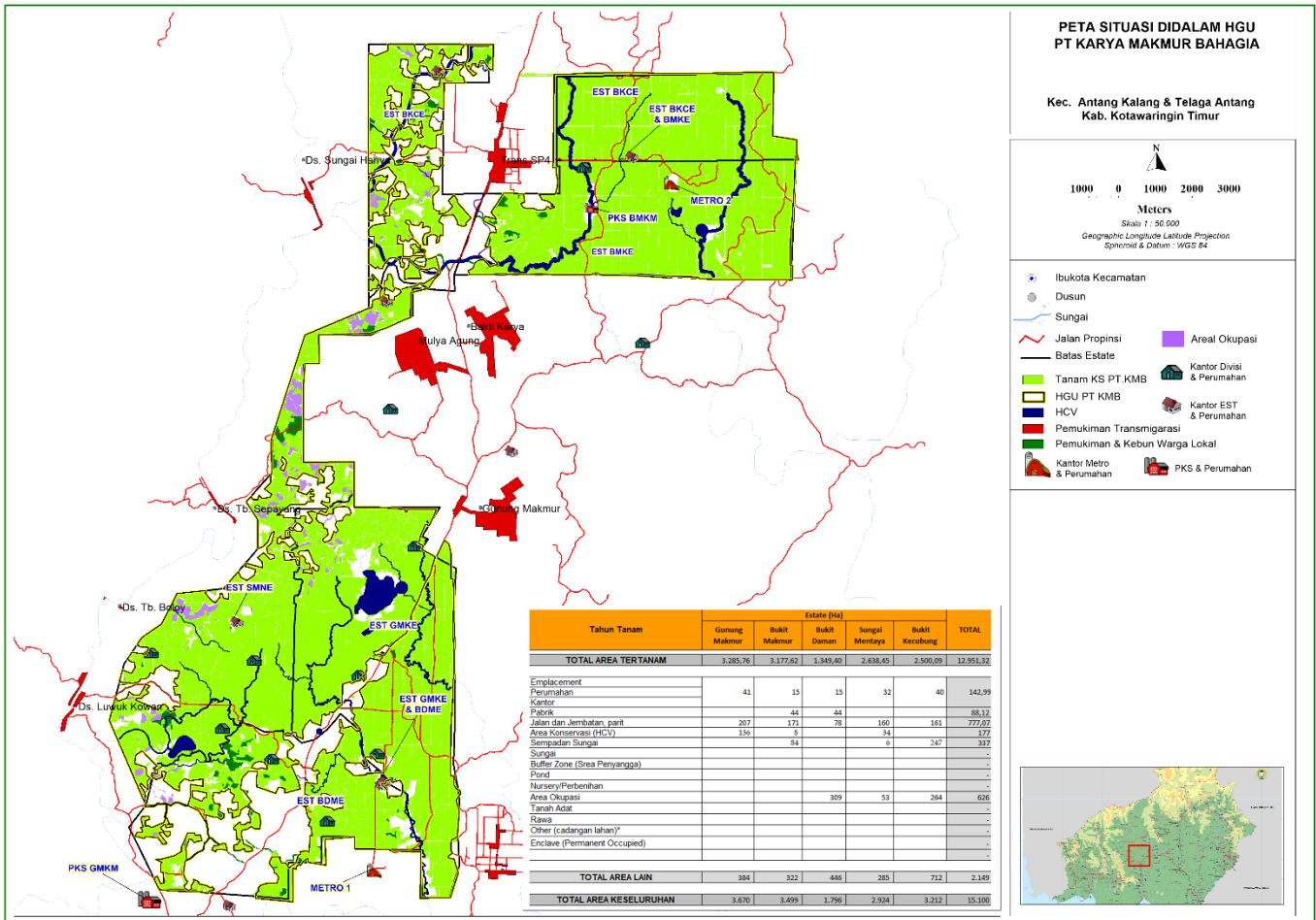
