Figure 1. Location Map of PT. Permata Putera Mandiri




Figure 2. Location Permit Map of PT. Permata Putera Mandiri




Figure 3. Map of HCV Area and Operational Project area of PT. Permata Putera Mandiri




Figure 4. Map of Forest Area Status of PT Permata Putera Mandiri




Figure 5. Land Cover Map of PT. Permata Putera Mandiri year of 2014




Figure 6. Topography Map of PT Permata Putera Mandiri




Figure 7. Soil Map of PT. Permata Putera Mandiri




Figure 8. Map of Customary Land Release from Karirif Village




Figure 9. Map of Customary Land Release from Atori Village




Figure 10. Map of Customary Land Release from Atori Village




Figure 11. Map of Customary Land Release from Udagaga Village




Figure 12. Map of Customary Land Release from Bubuko Village




Figure 13. Map of Customary Land Release from Benawa II Village




Figure 14. Map of Customary Land Release from Sumano Village




Figure 15. Map of Customary Land Release from Benawa I Village




Figure 16. Map of Costmary Land Release from Benawa I Village





Figure 17. Map of Customary Land Release from Puragi Village



# **SUMMARY FROM SEI ASSESSMENTS:**

A Participative PT Permata Putera Mandiri Social Environmental Impact Assessment (SEIA) has been conducted separately. The Social Impact Assessment (SIA) conducted by Sutji Rahayu Shinto; Miftah Ayatussurur; Elizabeth Nauw; Eno Sumarno; Anisa Swadesi on 14-30 November 2013 and the Social Environmental Impact Assessment (AMDAL) conducted by government accredited assessor (Ir. Sutrisno; Ir. Nasarudin Hasibuan; Ir. Lukman Hakim; Ir. Sugimin Sugianto; Doni Masditok, SKM). The SEIA main issue studied in the assessment is company profile and general condition of the project covering demographic data, economic as well as availability of public transportation. The assessment is also conducted to identify the demand of transparency aspect (principal 1) and legal compliance as well as applicable law (principal 2) stated in P&C RSPO Indonesia, land availability, community perception upon project, as well as the existence of conservation area based on HCV toolkit Indonesia. The SEIA covered a review of documentary sources are collected through Focus Group Discussion (FGD), in-depth interview, government policy, and village profile data; besides, the assessment also covered field observation and public consultation meetings for the villages within the project area and for affected landowners of surrounding communities. Summaries and findings of the interviews and public consultation meetings are included in the SEIA report.

# **SUMMARY FROM HCV ASSESSMENT(S):**

HCV assessment of PT Permata Putera Mandiri project conducted by the RSPO approved assessors Ir. Nyoto Santoso, MS (Team leader), Ahmad Faisal Siregar, S.Hut (Discipline Specialist on Participatory rural assessment; participatory mapping; socio-economic or cultural study; and conflict resolution), Eko Adhiyanto, S.Hut (Discipline Specialist on biodiversity), Sayidina Ali, Amd (Dicipline Specialist on biodiversity and participatory mapping), Rae Birumbo, S.Pi, Gilang Prastya Pambudi, S.Hut (Discipline Specialist on biodiversity and watershed management). The HCV assessment is peer reviewed by Dr. Ir. Jarwadi B. Hernnowo on 11 August 2014.

The assessment included satellite imaginary analysis, extensive field surveys, and public consultations with the communities living in the project area (Village of Atori, Village of karirif, Village of Winuoi, Village of karirif Benawa II, Village of Puragi, Village of Tawangire, Village of Benawa I, Village of Sumano). The HCV assessment report included recommendations for the management and improvement of the HCV found within the project area. The land cover at PT Permata Putera Mandiri consists of:

The HCV identified in the PT Permata Putera Mandiri project area clearly mapped. Based on identification and analysis of HCV presence in the area of PT. Putera Manunggal Perkasa there are found HCV 1.2, HCV 1.3, HCV 2.3, HCV 3; HCV 4.1, HCV 5 and HCV6 with total area coverage of 5,051.35 ha. Location Plan and the area will be opening new land was not in the area of primary forest, however on the Conversion Production Forest/Hutan Produksi Konversi (HPK)

### DOCUMENTATION OF FREE, PRIOR AND INFORMED CONSENT.

In accordance with RSPO requirements PT Permata Puter Mandiri obtained free, prior and informed consent from the local community that would be affected by the development of the concession area or land that would be opened. Until the new planting verification there land compensation has been shown, company has conducted the socialization for plan of PT Permata Putera Mandiri oil palm plantation and documented.

Available evidence of the land acquisitions process on the operational area of PT Putera Manunggal Perkasa for example:

- Customary land of Awe'e Tribe which located on Benawa I Village, North Kokonda District, South Sorong Regency, West Papua Province that width <u>+</u> 3,155 Ha at April 14<sup>th</sup>, 2013 No. 001/LR/PPM-EA/04.C/IV/2013 which representative of each clan.
- Customary land of Awe'e Tribe which located on Bubuko Village, North Kokonda District, South Sorong Regency, West Papua Province that width ± 3,327 Ha at July 29<sup>th</sup>, 2013 No. 008/LR/PPM-EA/05.C/VII/2013 which representative of each clan.
- Customary land of Awe'e Tribe which located on Sumano Village, North Kokonda District, South Sorong Regency, West Papua Province that width ± 330 Ha at April 14<sup>th</sup>, 2013 No. 003/LR/PPM-EA/09.C/IV/2013 which representative of each clan.

• Customary land of Iwaro Tribe which located on Puragi Village, Metamani District, South Sorong Regency, West Papua Province that width ± 3,494 Ha at July 09<sup>th</sup>, 2013 No. 004/LR/PPM-EA/08.C/IV/2013 which representative of each clan.

Statement letter which has been approved by head of District and also there are map of customary land release from each tribe that approved by representative of each customary head and agreed by head of district and head of village. All documentation of all land acquisitions was available.

# **SUMMARY OF PLANs:**

The management plan of PT Permata Putera Mandiri has incorporated the findings from SEIA (AMDAL), Social Impact Assessment (SIA) and HCV assessment for implementing the operational plans. Recommendations and also conclusion as result of SEIA and HCV has integrated in the management plan and consistent with RSPO P&C for New Plantings.

### **VERIFICATION STATEMENT:**

PT Permata Putera Mandiri opted for a document verification and field observation to conduct the New Planting Procedure. Mutuagung Lestari auditors have conducted desk study and discussions with sustainability officers during the desk audit. Two Mutuagung Lestari auditors were conducted the audit at their office in Jakarta on 23 June 2014 and 11 September 2014 to review and verify the relevant document and also interview with the management representatives. Field observation conducted on 27-28 June 2014 to project area of PT Permata Putera Mandiri. During the field observation to project area of PT.PPM there was identified land cleared for ± 291.56 Ha since 2014 for road access, nursery and infrastructure; however the cleared location was not in identified as HCV area. PT Permata Putera Mandiri has been made in compliance to Criterion 7.8 (High Carbon Stocks) of the P&C RSPO 2013. The calculation of High Carbon Stock (HCS) based on 2006 Intergovernmental Panel on Climate Change (IPCC) guidelines.

The SEIA (AMDAL) conducted by the government approved consultants as well as the HCV and SIA assessments conducted by RSPO accredited and approved assessors. PT Permata Putera Mandiri has adhered to RSPO New Planting Procedure and documented the assessments and plans are comprehensive and professionally carried out according to RSPO requirements and comply with the applicable RSPO Principles, Criteria and indicators for new plantings.

Land preparations activities carried out by PT. Permata Putera Mandiri were not in accordance with the RSPO new planting procedure regarding growers shall not commence any land preparation prior to



the expiry of the 30-days period of notification, however following the RSPO New Planting Procedure process, any party wishing to dispute the verification may pursue through the relevant RSPO Complaints and disputes procedures.
