Agropecuaria Santamaria S.A, Colombia plantation company, has applied to Control Union Malaysia Sdn Bhd to carryout re-certification activities in accordance with the National Interpretation of Colombia, as endorsed by RSPO Board of Governers on 7<sup>th</sup> November 2020, of its palm oil production.

The Recertification Audit is planned to commence on 15<sup>th</sup> July 2024 and will be completed on 19<sup>th</sup> July 2024.

Brief information about Applicant	The ASM Business Group is made up of the companies of Agropecuaria Santamaría S.A. located in the municipality of San Martín, department of Meta; this extraction plant has a capacity of 15 tn/h and its certified supply base is made up of plantations owned and/or managed by Santamaría with a productive area of 1,218 hectares, which is certified in the international standards of RSPO P&C and SCC (IP) since 2019; ISCC EU and ISCC PLUS since 2018.  Likewise, the Business Group is formed by the extraction plant ACEITES CIMARRONES SAS ZONA FRANCA PERMANENTE AGROINDUSTRIAL, located in the municipality of Puerto Rico, department of Meta, this extraction plant has a current capacity of 30 tn/hour and its supply base of certified RFF corresponds to 2,231 productive hectares of plantations owned or managed by Agropecuaria Santamaría in Puerto Rico Meta. It has also been certified since 2019 in RSPO P&C and SCC (MB) and in ISCC since 2018.  Additionally, there are the companies Extractora El Estero SAS and the plantation Vitis Olei SAS (2,200 ha) which are located in the municipality of Maní, department of Casanare, which are not yet certified in RSPO since they are within the deadlines established in the requirements of the system.  Grupo Empresarial ASM was established in 2021; the parent company is Agropecuaria Santamaría. Administrative processes such as human resources, sustainability, environmental, wellness, and occupational health and safety, among others, are transversal to all the operations of the companies that make up the business group.
