This is to inform that Pamol Kluang Palm Oil Mill under the Parent company IOI Corporation Berhad with RSPO membership number (2-0002-04-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located at Kluang, Johor, Malaysia.
