This is to inform that the above Management Unit under the Parent Company Harus Abadi Sdn Bhd with RSPO membership number 1-0280-19-000-00 has appointed SIRIM QAS International Sdn. The audit will be conducted from **2 December 2024** until **6 December 2024** against the requirements of:

- RSPO Management System Requirement for Group Certification of FFB Production 2022,
- Malaysia National Interpretation (MYNI) 2019 of RSPO Principles and Criteria 2018 for the Production of Sustainable Palm Oil

Harus Abadi Sdn Bhd is a private company which was established in 1994. The location is about 87 km from Lahad Datu town, 66 km from Kampung Paris and can be accessed through the government road, estate road and ferry. The plantation started planting Oil Palm trees in year 2002. All of its crops are sent to the Bukit Mas POM and Jeroco 2 POM (owned by Hap Seng). The estate is fully developed with 100% oil palm planting. It began planting oil palms in the year 1994.
