Notification of RSPO Certification Assessment of Goldtree (S.L.) Ltd, SIERRA LEONE RSPO Membership: 2-1017-19-000-00

To Whom It May Concern:

Goldtree (S.L.) Ltd, a subsidiary of Planting Naturals B.V has commissioned SCS Global Services to conduct an RSPO Re-Certification Assessment of its palm oil mill and plantations located at Old Mill Road, Jawei Chiefdom, Daru, Kailahun District, Sierra Leone. The assessment will be conducted on 1 Oil Mill and 5 Nucleus Palm Plantations.

SCS Global Services plan to conduct the Certification assessment of Goldtree (S.L.) Ltd from **20**th **to 24**th **October 2025**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&C for **Sierra Leone/2021**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
