## Notification of RSPO Re-Certification Assessment of Extractora Natural S.A, Ecuador RSPO Membership: 1-0115-11-000-00

## To Whom It May Concern:

Extractora Natural S.A. of Ecuador has commissioned SCS Global Services to conduct an RSPO Re-Certification Assessment of its palm oil mill and supply basin located near to Vía Viche – Esmeraldas, Km. 3- Parroquia Majúa, Esmeraldas, Ecuador. The assessment will be conducted of 1 Palm Oil Mill and 28 Outgrowers.

SCS Global Services plans to conduct the Re-Certification assessment of the Extractora Natural S.A. mill from **August 5 - 9, 2024**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&Cs for the **Ecuador/2021**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
