



## Notification of RSPO Re-Certification Assessment of SANTA ROSA S.A, Guatemala RSPO Membership: 1-0296-20-000-00

To Whom It May Concern:

SANTA ROSA S.A of Guatemala has commissioned SCS Global Services to conduct an RSPO Re-Certification Assessment of its palm oil mill and supply base located near Kilometro 156 Carretera al Semillero, Tiquisate, Escuintla, 5006, Guatemala. The assessment will be conducted of 1 Palm Oil Mill and 1 Oil Palm Plantations, 2 Outgrowers, 0 Scheme Smallholders.

SCS Global Services plans to conduct the Re-Certification assessment of the SANTA ROSA S.A mill from **August 5 – 9**, **2024**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&Cs for the **Guatemala/2021**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
