

## Notification of RSPO Re-Certification Assessment of Société des caoutchoucs de Grand Béréby (SOGB), Cote D'ivoire RSPO Membership: 1-0269-19-000-00

## To Whom It May Concern:

Société des caoutchoucs de Grand Béréby (SOGB) a subsidiary of Socfin SA has commissioned SCS Global Services to conduct an RSPO Re-Certification Assessment of its palm plantation and supply bases located at Plantation de la Dodo, Grand Béréby, Bas-Sassandra, Cote D'ivoire. The assessment will be conducted on 1 Oil Mill and 2 palm plantations supply bases.

SCS Global Services plan to conduct the Re-Certification assessment of Société des caoutchoucs de Grand Béréby (SOGB) from **6<sup>th</sup> to 10<sup>th</sup> October 2025.** The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&C for **Cote D'ivoire/2020**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
