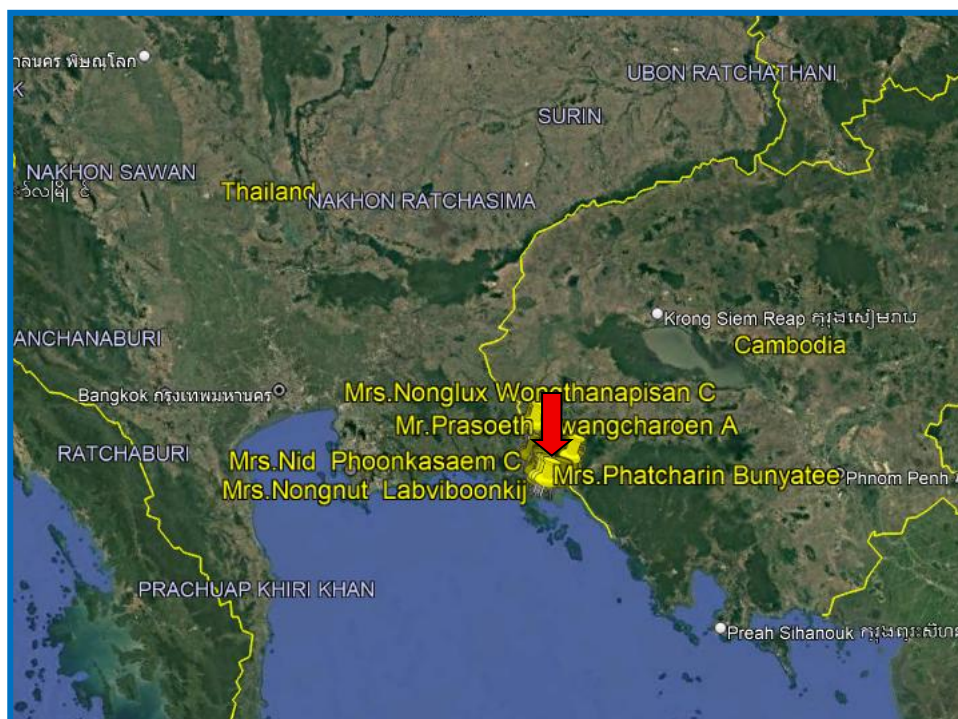


Figure 1: Group manager location

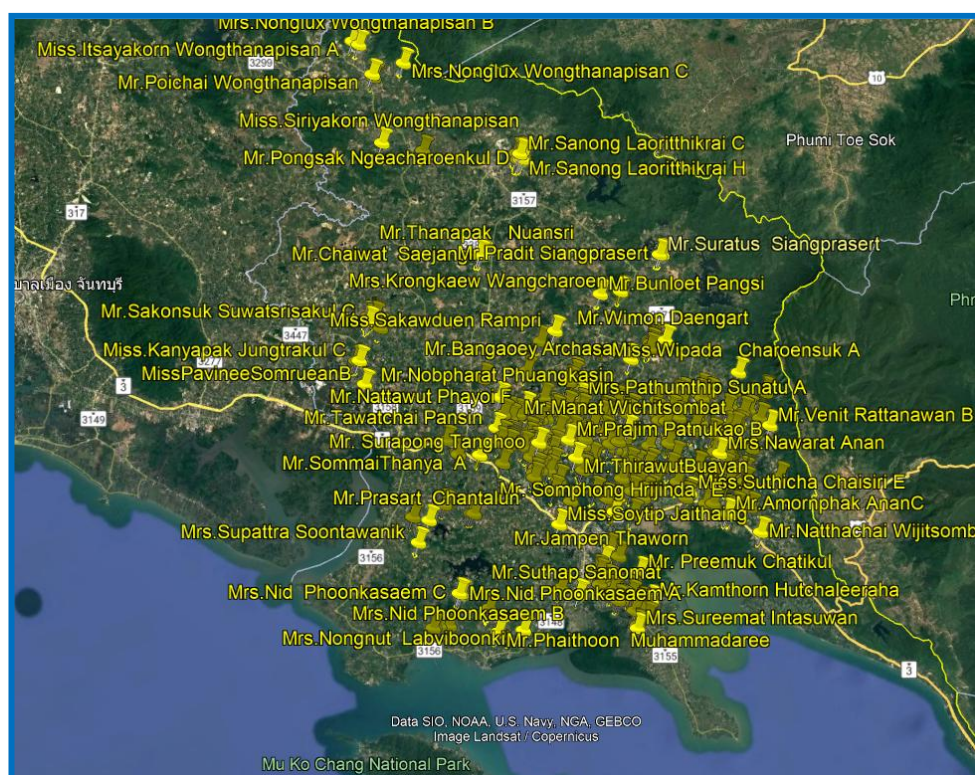


Figure 2: Member Oil palm plot location
