**1. Brief Updates from COP26 Campaign/BoG**

- The third ‘Task Force’ meeting of the COP26 campaign was organised on 15<sup>th</sup> June 2021 to discuss the next steps. The campaign plan is being revised due to capacity constraints and more updates will be provided in due course
- The BoG discussed the ongoing challenges and solutions related to the staffing challenges in the RSPO secretariat and more updates will be provided in due course

**2. Summary of proposed changes to the ‘Communication, Claims and Trademark documents**

- Secretariat shared the summary of changes (shared previously) for these documents based on the feedback and review so far and also noted the comments from OWG members during this meeting (please refer to the recording of this meeting)

**3. Regional updates for BIG4 (India, China, Indonesia, Malaysia) to increase CSPO uptake and RSPO’s impact**

- Secretariat shared key updates from BIG4 as highlighted in the presentation used during the meeting (attached)
- RSPO will be launching a global youth impact competition in July 2021 to invite submissions for innovative solutions related to sustainable lifestyle and sustainable palm oil
- RSPO is scaling up its efforts to engage better with members and stakeholders in Japan, South Korea, Australia and Singapore
- In the US, RSPO is monitoring the relevant legislations and preparing a position paper, in consultation with the MDSC. More updates will be shared in the coming weeks

**4. Key Action Items**

- OWG members are expected to invite their colleagues based in BIG4 regions to join the next meetings
- The RSPO assurance team is now in the process of finalising the 'Communications & Claims' document, which will be sent to the OWG and MDSC for approval
- The RSPO ACOP team will be preparing the uptake related data and analysis and we should be ready to present in the next OWG meeting. For the July meeting, we are also looking to invite a representative from the 'Singapore Institute of International Affairs' (SIIA) to share some highlights from their '[Haze Outlook Report 2021](#)' and other relevant topics for BIG4. This will be confirmed in the coming weeks.
